WHAT IS A TRAUMATIC BRAIN INJURY (TBI)?

A traumatic brain injury (TBI) can be defined as any mechanical force to the brain that results in loss of consciousness, memory loss or change in mental status after the injury event. The Centers for Disease Control (CDC) measures that about 1.4 million people sustain a TBI each year in the U.S. alone, usually as a result of a car accident or fall down injury. TBIs can be mild, moderate, or severe, depending on the resulting symptoms post-injury. The good news is that with most TBIs there is medical treatment that can be quite beneficial. Answer: In order to prove injuries related to a personal injury claim, not only do you have to prove that a negligent act caused your injuries but you must also prove that you suffered a real injury as a result of someone else's negligence. The only way to do this is through medical documentation. It is extremely important that injury victims follow up with their family doctor or another doctor after an accident and closely follow the treatment regimen recommended by the doctor. Without proper medical documentation from your doctors, you will lack the evidence needed in order to prove your personal injury claim.

LAURA CARPEY'S RECIPE OF THE MONTH

No Bake Strawberry Cheesecake Bites

INGREDIENTS

- 1 pound of strawberries
- 4 ounces cream cheese, softened
- 1/4 cup powdered sugar
- 1/4 teaspoon vanilla extract
- graham cracker crumbs or crushed graham cracker

INSTRUCTIONS

1. Cut off the tops of the strawberries and hollow out the inside with a pairing knife.
2. In a bowl, combine the cream cheese, powdered sugar, and vanilla with an electric mixer.
3. Fill each strawberry with the cheesecake filling using a spoon, knife, or a piping bag.
4. Dip the strawberry, cheesecake side down, into the graham cracker crumbs.
5. Keep refrigerated until served.
