YOU MAY GET FRUSTRATED WITH THE INSURANCE CLAIM PROCESS

The personal injury legal process can be complicated, confusing and take what seems like a very long time to resolve. But there is much work for your legal team at Carpey Law to do throughout the process.

Some injuries can take months if not years to reach maximum physical improvement. And during this time, depending on the extent of the injuries you may see many different doctors, perhaps in different specialties. During the various phases of a personal injury claim it is not unusual for people to think or feel:

- *That things are not moving fast enough.*
- *That it is taking a long time for information to be gathered (such as medical records or medical bills).*
- *That it takes a long time to find out what the insurance company or the insurance company's lawyers want to offer to settle the case.*
- *Even after the case is settled it can take additional time for all of the bills and liens to be paid.*

Remember that your legal team at Carpey Law is working hard for you but the insurance companies frequently use delay tactics in order to build your level of frustration so you will “want it to be finished” and will accept an unfair low offer in your case.

Understanding that this is a long process and deciding the stick with the process will make a huge difference in the value of your claim and the amount of money you receive as compensation for your injuries.

LAURA CARPEY'S RECIPE OF THE MONTH

Lamb Chops with Lemon, Thyme & Mustard Butter

These French-inspired lamb chops cook under the broiler, so they're quick and flavorful.

INGREDIENTS

- 4 Tbs. unsalted butter, softened
- 1 tsp. whole-grain Dijon mustard
- 1 tsp. fresh thyme leaves, lightly chopped
- 3/4 tsp. finely grated lemon zest
- 1/8 tsp. kosher salt; more as needed
- 1/8 tsp. freshly ground black pepper; more as needed
- 8 lamb loin chops (1-1/2- to 2-inch-thick chops; about 3 lb.), trimmed

INSTRUCTIONS

1. In a small bowl, mash together the butter, mustard, thyme, zest, salt, and pepper until well combined. Refrigerate until ready to use.
2. Position an oven rack 5 to 6 inches from the broiler element and heat the broiler to high. Line the bottom of a broiler pan with foil and replace the perforated top part of the pan. Arrange the chops on the pan. Season both sides of the lamb generously with salt and pepper. Broil until the first side is wellbrowned, about 8 minutes. Turn the chops over with tongs and continue to broil until they're well browned and the center is cooked to your liking, 3 to 5 minutes longer for medium rare (cut into a chop near the bone to check).
3. Transfer the lamb to serving plates and top each chop with a dab of the flavored butter. Serve hot.
